



Established in 2011, Novum Energy is a global energy trading and logistics group with its principal place of business in Houston, USA with additional offices in Latin America, Europe and Asia. The founding members of the Novum Group collectively represent over 80 years of industry experience and hail from oil supermajors, national oil companies and Tier 1 commodity trading houses. Novum bridges the physical energy supply chain by connecting producers with users and catering to the unique needs of its counterparties by providing innovative solutions. With a firm foundation in the distribution of crude and fuel oil, the Group has been branching out into additional energy products including gasoline and distillates.

Over the last decade, Novum Energy has built a firm and profitable business centered on the relationships it has developed with all parties in its supply chain. The Group is renowned as a stable and reliable counterparty with a strong business acumen and a dedication to safety, environmental protection and social responsibility.

Starting with a regional focus on the Americas, the Group began its global expansion in 2019. In a short space of time, Novum Energy's strong reputation has enabled it to achieve early success in Europe, East and West Africa and Asia. Moreover, it has continued its expansion in these markets through the investment in highly skilled and experienced employees. With a commitment to continuous growth, the Group is seeking to diversify its revenue base by both product and region.

Since its incorporation in 2011, Novum has moved over 150 million barrels of oil products and delivered 12 consecutive years of positive financial results without a single loss. These results have been achieved by means of a disciplined and rigorous credit, risk management and trading framework that is embraced by every employee of the Group. It is this attention to detail that sets the Group apart from the competition and positions it or future growth.

In 2021, the Group moved 25 million barrels and surpassed that figure in 2022 with **30** million barrels moved. The future looks bright for Novum Energy.

Novum Energy Trading Corp. (NETC) was established as a physical oil trading company in February of 2011 with Alfredo Vilas as its Founder and President. Novum started its operations by supplying HSD and HFO to various power generators in the Caribbean.

Facilitating the product and logistics needs for clients throughout the Caribbean, EMEA, Central Asia, Asia-Pacific and Latin America, Novum offers some of the most comprehensive and customized services in our sector. The Novum team has decades of expertise in trading energy products and works hard to understand each client's needs through every step of every transaction. No job is too small or too large.

With significant experience in energy products, Novum Energy understands the core of these industries and mobilizes relationships in a way that benefits clients by analyzing and understanding the nuances of the distillates, fuel oil and gasoline industries on a global scale.


Novum Mexico Trading S de RL de CV was incorporated in 2016 to focus on the import and distribution of refined products into the Mexican market. In 2019, Novum Energy Trading Corp completed its first sales in to East Africa, as well as distillate cargo sales from Europe to the US and WAF. In August 2020, Novum Energy Trading Pte Ltd was incorporated in Singapore and began trading in the Asian markets. In 2022, Novum opened an office in London.

Novum continues to meaningfully add to its trading teams in order to open opportunities across the globe. We will continue to grow the company by thoughtfully implementing a strict risk management philosophy whilst maintaining a close relationship with our growing base of business partners worldwide.

#### What We Trade

As a key player in the global energy market, we trade a variety of commodities that fuel the world's economies and transportation systems. Our portfolio includes a range of crude oils, fuels and feedstocks that are critical to meeting the energy demands of industries and individuals alike, including:

#### **North America**

In North America, Novum Energy Trading Inc. specializes in tailored market analysis and resource optimization. Over the past 5 years, the company has achieved an impressive 24-fold increase in sales volume, reaching over 8 million barrels in sales in the United States in 2022. In the United States Novum offers Ultra-Low Sulfur Diesel (ULSD) and gasoline in strategic locations like Houston and Brownsville, Texas.

#### Mexico

Novum entered the Mexican market in 2016, capitalizing on the energy reforms of the time that opened doors for private sector involvement. The company's tailored services and strategic initiatives swiftly positioned it as a prominent provider in the private oil supply sector throughout Mexico, efficiently serving all regions. Notably, Novum achieved a historic milestone by becoming the first non-Mexican entity to become licensed to import refined oil products into the country.

#### Caribbean

Novum offers private fuel storage and delivery throughout the Caribbean. Through efficient delivery, Novum serves a wide number of major companies in the region.

#### **South America**

In South America, Novum Energy S.A. (NESA) strategically operates in Argentina, serving both private and state-owned oil companies and extends its services across a spectrum of countries including Peru, Colombia, Chile, Bolivia, Uruguay, Paraguay, Brazil and Ecuador. Novum's approach is deeply rooted in understanding and adapting to the diverse needs of these nations, guaranteeing smooth access to fuels facilitated by an extensive logistics network and strong collaborative efforts with traders to ensure economical and timely execution. Our active engagement in the Amazon region showcases our commitment to innovation and sustainable solutions, solidifying our dedication to meeting the unique energy demands of South America.

#### Middle East, Europe, & Africa

Novum strategically engages in trade activities across Europe, the Middle East and Africa, with a particular focus on expanding operations in Africa. Our African initiatives commenced two years ago, aimed at addressing the unique challenges faced by countries in Central Africa with limited oil infrastructure such as pipelines and refineries.

In Africa, Novum adopts a specialized approach, maximizing storage facilities in Tanzania to cater to nations in Central Africa that lack typical oil logistics infrastructure. Our primary mission is to serve landlocked regions, including the Democratic Republic of Congo (DRC), Rwanda, Burundi, Uganda, Zambia, Malawi and Zimbabwe.

Our clientele in these regions is a vibrant mix of locally registered wholesalers and businesses, predominantly small to midsize enterprises, passionately dedicated to supplying diverse products across their respective markets.

To ensure seamless transactions and maintain competitive pricing for our discerning customers, Novum has successfully established agreements with reputable local entities. At Novum, we are committed to not merely conducting transactions but orchestrating transformation within the regional realms of trade.

#### Asia

Novum Energy Trading Pte Ltd (NPTE), incorporated in Singapore, is the Group's newest operating hub with a focus on the Asia-Pacific (APAC) as well as the Central Asia regions. Since its incorporation in 2020, the company has carved a niche for itself by focusing on both interregional and intra-regional trading. The company recently executed its first trade on the Platts market-on-close window opening up a new delivery stream for the Group. With a strong emphasis on trade finance, networks and relationships across the APAC region, Novum aims to firmly entrench itself in the Asian market.

# ENVIRONMENTAL PROTECTION & SUSTAINABILITY

#### **Environmental Protection & Sustainability**

#### Introduction

Sustainability is at the heart of Novum's development strategy.

We are **engaging with society** - ensuring that we protect and preserve those communities impacted by our operations; keeping our employees healthy, safe and secure in the workplace; and continuing to enhance our knowledge and skills through lifelong learning opportunities.

We are **protecting the natural environment** - implementing robust safety policies and procedures and taking every due precaution.

We are **investing in the future of our company** - ensuring responsible and sustainable business development accompanied by robust governance, integrity and accountability

As a global supply and logistics company, Novum is involved in the movement of crude, fuel oil, gasoline and distillates throughout the world via ships, barges, railcars and trucks, all of which carry an inherent risk. However, through robust safety policies, training and inspections, Novum has to date successfully managed to prevent environmental incidents throughout its operations. We are confident that we have the systems in place to ensure that our excellent environmental track record continues throughout our global operations.

#### **Environmental Policies**

Since Novum began marine operations, the company has never had a spill or environmental event that could be attributed to our own ships or barges. Nor have we had any incidents at sea. Every ship and barge Novum uses undergoes our screening process.

The vast majority of ships chartered by Novum are under 15 years old; few older ships are chartered on an exceptional basis and these ships are in possession of the highest Condition Assessment Program ratings. Every ship we use is in compliance with applicable domestic and international governing body regulations and must maintain those approvals in order to be used for the transportation of our products. Ship Inspection Reports Programs (SIRE), originally introduced by the Oil Companies International Marine Forum in 1993 as a tool to better evaluate the qualities of the ships used for transportation, are required to be up to date. As of 2024 new carbon emission regulations will be enforced globally. Novum is monitoring the situation while looking at software able to capture and report such emissions.

Special attention is given to river barges trading in sensitive geographical areas. Additional personnel have been hired for this specific purpose. In these areas Novum has started implementing a vetting ranking system that will help in identifying less optimal and efficient barges while strengthening Novum's ability to reduce their use. Together with new operations manuals implementation and consistent crew training, the risks associated with every operation are prudently managed.

#### Additional external vetting process

In accordance with OFAC and other global trade regulations and sanctions requirements and policies related to countries, political systems and individuals, additional vetting is carried out via the use of a dedicated software program created by Windward. This software is extensively used throughout our industry.

All third party nominated vessels must undergo the same vetting processes.

#### **Terminal Vetting**

Vetting is not limited to ships alone. Whenever new tanks are leased, an inspection of these tanks and the terminals where they are located takes place. Safety is always paramount and before any product is introduced into any tank, a vetting operation is carried out by internationally recognized inspection companies using one or more of their certified inspectors.

#### **Employee Training**

While senior Novum employees have gained their significant experience at other international trading organizations, junior team members are trained in-house by a few selected senior members of our team on a wide range of matters such as Tanker Operation, Voyage Orders and Inspectors Nominations. These – together with instructions on compliance with specific port and terminal requirements for different sized vessels and types of cargo – ensure that any potential operational risks are reduced to a minimum. Should an operational problem be encountered, it is Novum's strict policy to address it immediately in order to find the root cause of the problem and share any findings with all operators. A tanker operations manual has been issued and distributed among the operators.

#### **Fuel Oil Operations in the Americas**

Novum has historically been very active delivering fuel oil throughout Latin America and the Caribbean, from Mexico to Argentina, Aruba to Barbados, the Dominican Republic, among others. Such deliveries are performed by our time-chartered fleet of appropriately sized vessels as well as spot-chartered vessels loading out of our leased storages in Puerto Rico and St Eustatius. In 2022, Novum performed approximately 200 moves in the Americas with zero environmental impact.

#### **European Fuel Oil Operations**

Novum's fulfilled a term contract for the delivery of fuel oil into Morocco during 2022 which required us to time-charter seven different vessels and 10 additional spot ships in just one year. We undertook over 100 shipments, including many ship-to-ship operations. Novum has recorded no spills and experienced no marine operations impacts.

#### **Distillates**

Novum has completed a term deal with the government of Puerto Rico for the supply of diesel oil to the island. Novum has time-chartered the American-flagged barge Double Skin 601 to undertake the distribution of the diesel from the storage terminals at Puerto Rico and St Croix. We have performed over 75 voyages on the DS 601, all without incident. In light of our successful operations on the island, Novum's contract was extended and we have chartered a second American-flagged barge, the Double Skin-508, to transport the increased volume.

Novum sources gasoline and diesel for supply to Mexico. Our domestic inland barges regularly deliver to our Brownsville storage facility. We have performed countless voyages of time-chartered double-hulled barges since we began supplying the Mexican market in 2017.



#### **Brownsville Operations**

Our longt-term Brownsville storage has been the hub for the distribution of gasoline and diesel via tank trucks or rail cars into Mexico This is one of Novum's most intensive land-based operation, from where we move approximately thirty (30) trucks per day.

Energy has the capacity to load railcars at Brownsville, although these operations are currently paused due to market and regulatory conditions in Mexico. Since the business commenced in 2017, we have performed over 80,000 operations and experienced only two minor truck incidents, which were beyond our control. Novum and its transport company ensured that the small amount of spilled product was fully cleaned up and that there was zero impact on the local environment.

Given that all our trucks load at third party terminals, each terminal has its own procedures for the registration and approval of such loads. Typically, this process requires the submission of commercial and liability insurance policies, vapor certificates and driver information. In addition to any terminal procedures, Novum imposes additional requirements on trucks, including the possession of GPS tracking, spill kits and further permits, as well as driver protection provisions such as the obligation to wear steel toed boots and safety vests. Novum Energy's carriers comply with the highest safety standards in the Oil and Gas industry, which has allowed us to provide services to oil majors such as Exxon, BP and others.

#### **Africa Operations**

In addition to our business in Morocco, Novum has expanded into other parts of Africa, where we supply our customers ex-tank from storage terminals including in Dar es Salaam, Tanzania. Since January 2022, a total of approximately 300 trucks per month have lifted product from our leased terminal, all without incident. From January 2023 we expanded our reach in East Africa to include further storage capacity in Beira, Mozambique for delivery onto our customers' nominated trucks. In 2023 Novum further expanded its customer base into West Africa.



#### **Environmental Innovation**

Novum is involved in discussions regarding the development of an innovative method for the sampling of petroleum products from shore tanks. This method, internationally patented, would allow for a remote controlled and entirely automated sampling of product out of any shore tank 24/7/365 without the need for an inspector to climb to the roof of the tank to open sampling ports that release gasses in the atmosphere. The benefits of the ATS system are vast – a clean carbon footprint, better tank turnaround, manpower savings, immediate tank quality results, consistency of sampling and analysis, demurrage savings and refinery output optimization.

#### **Investing in Solar Energy**

Novum Energy has invested directly with the Government of Morocco in Maroc Photovoltaique SARL, a company developing a solar PV project with capacity of up to 150 MW in Ain Bin Mathar, Jerada province in northwest Morocco. Connection and grid access agreements have been executed in 2022 with a 24-year land lease and environmental studies have been completed. This project is part of the Moroccan government's ambition to raise its renewable energy share to 52% by 2030 and reduce fuel oil and diesel imports from Spain for power generation.



#### **Our Carbon Footprint - Assessment and Reduction**

Novum recognizes the environmental impact of its carbon footprint and accepts the need for change to protect the world we live in. We believe in the energy transition and are striving to work with like-minded partners and technologies to contribute to this transition. Part of this journey involves the analysis and evaluation of the emissions generated from our operations. To better understand this, we are currently working with Carbon Chain who will evaluate and report on our carbon footprint. These partners will then collaborate with us on strategies to reduce our emissions and accelerate our transition to a net zero future. We currently expect to execute a finalized carbon footprint action plan in 2024.

# **SOCIAL RESPONSIBILITY**

We balance our generous compensation schemes, flexible working practices and commitment to work-life balance with rigorous training and robust standards of behavior.




#### Diversity, Equity, & Inclusion

#### **Corporate Governance**

#### Introduction

Novum Energy's corporate governance structure is built on a foundation of policies, procedures and processes that address corporate responsibility and conduct, prudent fiscal management, conflicts of interest, risk management and best practices in hiring and doing business. This enables the company to expand transparently and with confidence and position Novum for long-term success.

#### Objectives

The application of constitutive policies, procedures and best practices enable Novum to determine its direction and performance through effective management of the relationships among our shareholders, management, employees, business partners, all other stakeholders and the communities we serve and live in.

Our governance framework has been developed to:

- Set executive limitations by protecting and empowering the way the Company is directed and managed.
- Connect Novum's leadership team with employees to ensure that all are on the same page regarding the Company's strategic direction, its philosophy, and its strategies to achieve business objectives.
- · Nurture a culture of hard work, excellence in performance and doing business the right way.
- · Control risk and ensure accountability, transparency, and integrity across the organization.
- · Prevent conflicts of interest amongst stakeholders.
- Focus on the strategic goals we seek to accomplish as a team by increasing and sustaining shareholder value while remaining competitive, sustainable, relevant, and legitimate..

#### Our Principles and Values

We embrace innovation and have cultivated a culture that prioritizes compliance, teamwork and integration. Novum's leadership team is entrusted with the responsibility of not only nurturing but also continually reinforcing this culture throughout the organization.

#### **Code of Conduct and Risk Management**

**Novum's Code of Conduct** serves as a guiding document for every internal policy and framework, outlining the fundamental principles and core values that are obligatory for every member of our organization. This code sets the standard for ethical behavior, reinforcing our commitment to responsible corporate citizenship. Our approach is further grounded in stringent compliance with applicable global anti-bribery/anti-corruption laws, sanctions and KYC/AML laws, standards and regulations. Our ABC policy is a cornerstone of our governance framework. It applies uniformly to every entity within the Novum family, extending its reach to encompass our directors, employees, agents and, where applicable, third parties.

**Novum's Risk Management Policy** is one of the core responsibilities of the Group's leadership and it is central to our decision-making processes. We seek to identify and manage the market, financial and operational risks associated with global supply and logistics. Our Risk

Management Policy establishes guidelines for employees to manage these risks and describes how the Group defines, manages and mitigates its exposures and assigns responsibilities for managing our risk management program. Novum has undertaken an initiative to enhance our ETRM system to be a robust and comprehensive tool whereby Novum can effectively identify and prevent various risks related to commodity price volatility and market risk. Having this tool provides robust controls and enhanced reporting for Novum's Leadership Team to effectively consider and manage risk.

Effective risk management is crucial in helping the Company achieve its objectives of preserving its overall financial strength for the benefit of all stakeholders and safeguarding its ability to continue as a going concern while generating sustainable long-term returns. With a priority of fraud prevention, the Leadership Team with its significant risk management expertise, is responsible for setting, approving and monitoring the organization's risk management policies, credit policies and internal controls.

But just as importantly, our risk policy, risk and position as well as VaR limits, are the other cornerstone of the prudent management of our business.

All of this is supported by compliance vetting platforms such a KOMGO© and other digital data repositories and management tools.

#### **Market Conduct**

Novum requires all employees to behave and trade in a way that is appropriate and in compliance with market-abuse rules and regulations. All trading activities must be performed for genuine economic reasons and not to mislead or manipulate the market. We do not condone collusive or abusive strategies, or trading whilst in possession of inside information. We further ensure that all our transactions fall outside the scope of market abuse or market manipulation. All employees must be familiar with the market-abuse rules and regulations applicable to their activities and are expected to act in accordance with them at all times.

#### **Policies and Guidance**

Novum Energy's Code of Conduct was established to outline our principles, standards and values. This includes our expectations for ethical behavior, integrity, professional competence and confidentiality. Policies of note under the Code include:

- Our Whistleblower policies and apparatus provide stakeholders (including employees, suppliers, customers and members of the public) with simple, safe, confidential and reliable ways of reporting suspected incidents of non-compliance.
- Novum's policies and procedures on Conflicts of Interest enable us to identify and manage situations of actual, potential and or perceived conflicts of interest.
- Novum has invested considerable time and resources into devising and implementing a robust Anti-Bribery and Anti-Corruption Policy (or ABC policy) that clearly sets out the requirement of all employees and business partners to uphold our position against bribery and corruption. We routinely provide information, training and guidance on how to recognize and deal with bribery and corruption issues.

#### Onboarding Process and KYC Compliance

Novum Energy is a company that cares how and with whom we do business.

We invest significant energy and resources in risk management and compliance, headed by experienced professionals and supported by sophisticated IT support systems.

In order to identify and track the veracity of the data and documentation of our trading counterparties, Novum Energy implements a rigorous Know Your Customer (KYC) compliance procedure.

We collect information, perform a deep analysis to assess security and verify the counterparty's authenticity.

Novum Energy uses an online platform called Komgo to ensure the security and transparency of communications with commercial and financial partners. Komgo is a joint venture of banks, independent traders and energy majors. Through its simple, efficient, secure and encrypted software, Komgo enables Novum Energy to undertake compliance advanced screenings to:

- Prevent anti-money-laundering (AML)
- · Identify politically exposed persons (PEP) and those subject to sanctions
- · Meet Office of Foreign Asset Control (OFAC) requirements
- · Identify and verify the entity and their Ultimate Beneficial Owners

#### Reviewing and Refreshing our Governance Policies

As the Group grows its global footprint, it is aware of the need to continuously risk-assess, review and refresh its governance policies and procedures to ensure they remain of the highest standards and continue to be relevant to the organization.

#### Transparent Framework

Our corporate framework is characterized by clarity and transparency. We have established a clear framework that governs the conduct of our business, emphasizing ethical practices, compliance with regulations and a commitment to sustainability. Whether it is conflicts of interest, corporate opportunities, confidentiality, fair dealing, proper use and protection of company assets and reporting of any illegal or unethical behaviors, our policies and our approach aspire to emulate public company mandates while remaining a nimble privately-owned company.
